II. APPROVAL OF MINUTES

Referring to Item II: Attachment A, Conners entertained a motion to approve the August 30th, 2022, TPSG Subcommittee meeting minutes.

MOTION by Harrall, SUPPORT by Sundblad, to approve the August 30th, 2022, TPSG Subcommittee meeting minutes as presented. MOTION CARRIED UNANIMOUSLY.

III. OPPORTUNITY FOR PUBLIC COMMENT

No public comment.

IV. <u>FY2023 FUNDING</u>— Referring to Item IV: Attachment A, Joseph presented the discussion on the FY2023 funding.

GVMC recently received updated revenue targets for FY2023 as well as authority to spend some of the carryover funding as MDOT's way of paying back the local program for spending more than 75% of the FY2022 August redistribution funding. Additionally, up for consideration is \$199,500 in HIP-COVID relief funding that needs to be programmed and obligated prior to the end of FY2024. This was switched out for a different funding source in a FY2022 project and remains unprogrammed currently.

At this meeting, the TPSG Subcommittee is tasked with reviewing the FY2023 TIP list and making recommendations that will move forward for Technical and Policy Committee consideration at their combined December meeting.

STP-TMA, STP- Flex Kent, STP-Rural, and STP-Flex-TMA

Joseph noted a correction to the STP urban funding. Due to the Federal Aid Buyout of \$61,000, the amount of STP urban funding that needs to be programmed is now \$1,400,000.

Conners proposed to bring all the projects to 80/20; however, Joseph stated this would take \$2,000,000, so that cannot be accomplished. Connors instead proposed to increase funding percentages proportionally until all STP urban money is spent on existing projects that have not been maxed out yet. Harrall noted that the Kent County Road Commission would like their 100th Street project to be funded to the full 80/20. Joseph suggested they could use flex funds for this. Discussion ensued.

Henckel expressed concern regarding obligating funds for the Gezon Parkway project because the City of Wyoming is waiting on the survey to be completed. Discussion ensued.

Connors suggested the Alpine project for the City of Walker could be added back to FY2023 if needed. Harrall noted that the 28th Street project has received environmental clearance and this project could be moved quickly as well.

It was recommended that the STP-TMA, STP-Flex Kent County, STP-Rural, and STP-Flex-TMA funds are utilized as close to the maximum federal limit as possible.

TAP

Joseph explained there is \$3,600 in TAP funding that must be allocated to a project. It was recommended that the \$3,600 in TAP funding be allocated to the Collindale Avenue project for the City of Grand Rapids.

CRP

There is \$7,470 in CRP funds that must come out of a CRP funded project. The two CRP funded projects are the City of Grand Rapid's Turner Ave project and Kent County's 84th Street roundabout project. Bennett agreed to have the \$7,470 of CRP funding be decreased from the Turner Ave project.

EDC

The EDC target has been updated and is now approximately \$990,000; however, Joseph explained it is not necessary to make recommendations with EDC funds today.

Harrall requested that the \$650,000 in EDC funds be allocated to the Kent County Northland Dr. project. Joseph stated that due to utilizing EDC carryover funds, \$650,000 could not be allocated without impacting future year projects. However, the difference between the original target and the new target could be allocated, which is \$11,000. It was recommended to add \$11,000 in EDC funds to the Kent County Northland Drive project.

HIP-COVID

The HIP-COVID relief funding can be obligated in FY2024; however, that is the last year it can be utilized.

Bennett suggested applying the \$199,500 in HIP-COVID funds to the Turner Ave project to supplement the removal of the CRP funds, then the remaining HIP-COVID relief funds could be used to supplement other projects that are below 80/20. Discussion ensued.

Harrall noted that Kent County has a bridge project in FY2024 for Packer Drive and Rouge River Drive that is unfunded. If the HIP-COVID relief funds were allocated to this project, it could be obligated in FY2023 instead. Discussion ensued.

Bennett inquired if there is an outcome where no one loses any project funding. It was then instead recommended to decrease the Kent County 84th Street roundabout CRP funding by \$7,470, and then allocate all \$199,500 of the HIP-COVID relief funding to the Kent County bridge in FY2024 instead.

Conners entertained a motion to allocate the FY2023 funding.

MOTION by Kirkwood, SUPPORT by Harrall, to recommend to the Technical Committee to approve the FY2023 STP, EDC, CRP, TAP, and HIP-COVID relief funding allocations as discussed. MOTION CARRIED UNAMIMOUSLY.

RE: FY2024 Funding Allocations and Programming

GVMC recently received updated revenue targets for FY2024. A summary of what needs to be recommended for programming in FY2024 is as follows:

^{*}Because EDC is a state funding source, these funds have more flexibility related to the fiscal year to which they can be applied.

Staff is requesting TPSG review and action to recommend changes to the FY2024 TIP list to align with these new targets and remain fiscally constrained as federally required. TPSG programming recommendations will be presented to the Technical and Policy Committees at their September meetings.

To assist in Subcommittee review, attached is the list of FY2024 projects with applicable funding sources, including current funding levels and estimates to get funding levels to maximum federal participation.

Subcommittee members may also review the FY2023-2026 illustrative lists on the GVMC website (https://www.gvmc.org/tip) for potential projects to propose for funding.

Staff observations by funding source are summarized below.

STP-Flex-Kent County:

- Impacts one City of Walker project (Kinney Ave Reconstruction)
 - The federal amount for this funding source needs to be lowered by \$67,000 to align with the new target.

STP-Rural-Kent County

- Impacts one KCRC project (100th Street Reconstruction)
 - The federal amount for this funding source needs to be lowered by \$34,000 to align with the new target.

Carbon Reduction Program

- Only one project programmed with this funding source City of Walker's roundabout project at Center Drive NW – is not currently programmed with maximum federal participation.
 - One potential recommendation could be to increase the federal amount by \$66,000 to align with the new target and also almost balance the amount lost on their Kinney Ave project.

STP-Flex-TMA and STP-TMA

 Most of the projects with these funding sources were programmed with more than the required amount of local match.

One additional situation for Subcommittee consideration during the programming discussion: In 2021, TPSG, Tech, and Policy Committees recommended allocating \$285,000 in HIP-COVID Relief funding to The Rapid's Transit Master Plan project. Because of the timing of the project and FTA's grant award timeline and process, the project was programmed in this fiscal year (FY2023).

When the word came down that unobligated COVID Relief funding was going to be rescinded as part of Congress' debt ceiling deal this summer, it was indicated that the applicable funds that had been allocated to transit projects would not be clawed back. However, that turned out to not be the case and now The Rapid's project is \$285,000 short in funding while the planning process has already begun. GVMC staff is working with The Rapid and MDOT to try to find the least disruptive solution to allow this important regional project to move forward and will provide an update on progress and ask for Subcommittee input at the meeting.
